What will I learn on this course?

This qualification is designed to enhance your knowledge and understanding of cybersecurity. It provides basic insights into various forms of cybercrime, routine protective methods, and relevant legislation such as GDPR and The Computer Misuse Act. Additionally, you will gain practical skills in managing user access controls using cloud services.

By the end of this course, you will be able to:

- Identify Different Forms of Cybercrime and Possible Motives: Understand the various types of cybercrime and why they occur.
- Outline the Effects of Cybercrime: Learn how cybercrimes can impact both individuals and organisations.
- Describe Tactics Used by Cybercriminals: Gain insights into the methods used by cybercriminals to defraud people.
- Identify the Importance of Cybersecurity Testing: Recognise why regular testing is crucial for maintaining cybersecurity.
- State the Importance of Cybersecurity Testing: Articulate the significance of ongoing testing practices.
- Set Up User Access Controls: Acquire practical skills to configure user access controls effectively.
- Understand Protections and Responsibilities in Legislation: Identify the legal protections and responsibilities for individuals and organisations as outlined in key legislation, including GDPR and The Computer Misuse Act.
- Describe Ethical and Unethical Conduct: Learn about ethical standards and practices in cybersecurity, including what constitutes unethical behaviour.

Syllabus

You will follow the Gateway Qualifications Level 1 (L1) syllabus, which offers a comprehensive introduction to the field of cybersecurity. The syllabus covers both theoretical knowledge and practical skills, preparing you to understand and navigate the cybersecurity landscape effectively.

Proof of Learner Identity

List of documents to show proof of learner identity

List 1: One item required

- o Passport.

- Bank or Building Society book.

- ES40 and JSA agreement.
- Medical card.
- o Services identity card.
- Household Utility bills.
- o Bail sheets.
- Original birth certificate.
- Marriage certificate.
- o Senior Citizen travel-pass with photograph.
- Any other form of ID.
